INSTRUCTIONS

- A Member desiring to exercise vote by Postal Ballot may complete the Postal Ballot Form and send it to
 the Scrutinizer in the attached self-addressed postage pre-paid envelope. Postage will be borne and paid
 by the Company. However, envelopes containing Postal Ballots, if sent by courier at the expense of the
 registered Shareholder will also be accepted.
- 2. The self-addressed envelope bears the address of the Scrutinizer appointed by the Company.
- 3. This Postal Ballot Form should be completed and signed by the Shareholder. In case of joint holding, this form should be completed and signed (as per the specimen signature registered with the Company) by the first named Shareholder and in his/her absence, by the next named Shareholder.
- 4. Unsigned Postal Ballot Form will be rejected.
- Duly completed Postal Ballot Forms should reach the Scrutinizer on or before August 12, 2016. Postal Ballot Forms received after this date will be strictly treated as if the reply from such Member has not been received.
- 6. Voting rights with one vote per share shall be reckoned on the paid up value of shares registered in the name of the Shareholders as on July 1, 2016.
- 7. In case of shares held by companies, trust, societies etc, the duly completed Postal Ballot Form should be accompanied by a certified copy of the Board Resolution /Authority and preferably with attested specimen signature(s) of duly authorised signatory giving requisite authority to the person voting on the Postal Ballot Form. In case the Postal Ballot Form is signed by the holder of power of attorney, reference to the power of attorney registration with the Company should be mentioned in the Postal Ballot Form.
- 8. The Scrutinizer's decision on the validity of a Postal Ballot Form shall be final.
- 9. A Member may request for a duplicate Postal Ballot Form, if so required. However the duly filled-in duplicate Postal Ballot Form should reach the Scrutinizer not later than the date specified at point no. 5 above. - 10. Members are requested not to send any other paper along with the Postal Ballot Form in the enclosed self-addressed postage prepaid envelope as all such envelopes will be sent to the Scrutinizer and any extraneous paper found in such envelope would be destroyed by the Scrutinizer.

The Company is pleased to offer e-voting facility as an alternate, for all the Members of the Company to enable them to cast their votes electronically instead of dispatching Postal Ballot Form.
